City School District of Albany School Enrollment Projections

Introduction

In October 2011, the City School District of Albany authorized the Capital District Regional Planning Commission to prepare district-wide school enrollment projections for the 2012-13 through 2016-17 school years.

The following is a description of the data, assumptions, activities, and trends that influence the number of students enrolled in the City School District of Albany, and the projections.

It should be noted that the uncertainty associated with charter school activity in Albany makes it difficult to project future enrollment in the city school district. Until there is some stability in charter school enrollment, public school enrollment will continue to be somewhat unpredictable.

Base Data

The preparation of the projections depended primarily upon the cohort survival methodology. Supporting data included the following:

- 1. The 1990, 2000, and 2010 Census information on the number of persons and housing units located within the school district;
- 2. Historical school enrollment data beginning with the 1992-93 school year;
- 3. Annual birth data for the period 2002-2009;
- 4. Charter and private school enrollment, and
- 5. Building permit and existing home sales data.

A series of projections was prepared using the cohort survival method. Using this method, survival ratios are derived by dividing the number of students in any given year by the number of students in the succeeding grade the following year. The survival ratio for kindergarten enrollment was derived by dividing the number of kindergarten students in any given year by the number of births five years earlier. Additionally, the survival ratio for pre-kindergarten enrollment was derived by dividing the number of pre-k students in any given year by the number of births four years earlier. The historical enrollment data were derived from the First Attendance Period Enrollment records taken during the last week in September that were provided by the District, and from Public School Enrollment and Staff reports published by the New York State Department of Education. The final set of projections was prepared upon review of the historical survival ratios and the other factors as noted below.

Historical Enrollment Trends

Based upon conversations with District officials, the decision was made to include pre-Kindergarten students in the total enrollment for the 20 year period shown in the Tables section, though District figures have only included those students in total enrollment since 2009-10. Pre-Kindergarten is not mandated by the New York State Department of Education, leading to significant variability in enrollment. Pre-k enrollment has trended upward during the last 20 years, from the low 100s in the early 1990s to the mid-300s during the mid-2000s, and reached over 500 students for the first time this year.

Additionally, with the exception of 2003-04, integrated special education students are included in the grade totals, rather than in the special education total. In 2003-04, integrated high school students were not included in the grade totals. The special education total includes in-District self-contained students in all grades. Students receiving special education services outside of the District are included in a distinct line from 2003-04 onward.

Finally, a distinction was made beginning in 2010-11 between the Montessori multi-grade class sessions, and the traditional grade sessions. For the purposes of the projections included in this report, the multi-grade Montessori classes were broken down into their individual grades, and combined with the traditional grade sessions.

The data shown on Table 1 represent the number of students enrolled by grade between 1992-93 and 2011-12. Overall enrollment rose steadily from 1992-93 through 1998-99, surpassing 10,000 students in 1997-98. Following a peak of 10,460 in 1998-99, enrollment declined gradually until 2008-09, hitting a low of 8,645 students. After hovering at approximately 8,700 for two years, enrollment rose to 8,880 this year.

Kindergarten enrollment fluctuated between the mid-700s and the mid-800s for the ten year period between 1992-93 and 2002-03, and then declined steadily to the high 600s by 2006-07. It dropped again to the mid-500s for two years, then rebounded to the mid-600s in 2009-10 and 2010-11. 2011-12 Kindergarten enrollment was 732.

As shown on Table 2, Pre-K through 5th grade enrollment rose from 4,681 in 1992-93 to 5,363 in 1998-99. Subsequently, it experienced a decline to 3,752 in 2008-09. The last three years, elementary enrollment has increased; this year's enrollment was 3,893.

Enrollment in grades 6-8 generally increased through 2000-01, from 1,596 in 1992-93 to 2,053 in 2000-01. It declined very gradually for three years before jumping back up to peak at 2,064 in 2004-05. Following that one-year increase, middle school enrollment resumed its decline, and finally stabilized in the mid-1,400s from 2008-09 through 2010-11.

Enrollment in grades 9-12 generally increased from 2,082 in 1992-93 to a peak of 2,826 in 2006-07. After declining to 2,018 in 2010-11, it rose slightly to 2,116 this year.

Grade-to-Grade Survival Ratios

A review of the historical grade-to-grade survival ratios shows mixed results for this year's ratios as compared to the historical averages. The following table identifies the grade-to-grade survival ratio last year compared to the five- and ten-year average for each grade.

Kindergarten-to-1st and 2^{nd} -to- 3^{rd} grades had survival ratios that were higher than the historical averages. 3^{rd} -to- 4^{th} through 6^{th} -to- 7^{th} grades all had survival ratios that were lower than the historical averages. Finally, 7^{th} -to- 8^{th} through 11^{th} -to- 12^{th} grades had survival ratios that were higher than historical averages.

Live Births

Due to the institution of a new geo-coding system, live birth data prior to 2002 is not available from the New York State Department of Health. The number of resident live births in the City of Albany from 2002 through 2009 is listed in Table 3. Births were projected for 2010 and 2011 based on the historical data.

Births have remained between the high 1,100s and the low 1,300s. The largest number of live births occurred in 2007 at 1,316. The past two years of data show births stabilizing around 1,260.

Based on building permit records, there has been limited new residential development in the City of Albany in the recent past.

Housing Turnover

Due to Albany's large housing stock, existing home sales play a larger role in school enrollments than new residential construction. It bears noting that existing home sales both in the City of Albany and across the Region have dropped in recent years. From 1997 through 2007, existing home sales in the City rose from 408 to 760 in 2005. In 2007, existing annual home sales in Albany dropped to 632, and by 2009 had dropped to 507. 2010 annual home sales in Albany further declined to 424.

Another potential factor in future enrollment growth is the availability of affordable housing in the City. Based on the 2010 Census, 63.4% of the occupied housing units in the City were renter-occupied. Housing turnover, especially in the rental housing market, reinforces the need to monitor enrollment on an annual basis.

Charter and Private/Parochial Schools

The first charter school in the Albany School District, New Covenant Charter School, opened its doors in September 2000. Today, there are 11 charter schools within the District. As noted in Table 4, charter school enrollment has increased steadily since 2002 (the first year of record-keeping). The number of District students enrolled in charter schools is listed in Table 4. In 2002-03, 824 students attended charter schools. In 2011-12, 2,249 City School District students were enrolled in charter schools, giving charters in the District a 20.21% market share. This substantial increase has undoubtedly affected District enrollment.

District records from 2008-09 through 2011-12 indicate that the number of students attending private and parochial schools has dropped, from 1,481 in 2008-09 to 1,254 this year. The continuing economic downturn and the rise in charter schools are likely factors contributing to decreasing private school enrollments.

Enrollment Projection Assumptions

Since 2000, 12 charter schools have opened in Albany, one of which has since closed. The challenge in preparing enrollment projections is partially attributable to the opening and closing of charter schools since the public schools are required to accommodate the surge or decline in students due to the sudden and oftentimes uncertain changes associated with the status of charter school located in the district. The status of charter schools requires continuous and constant monitoring, due to the impact that they have on public school enrollment.

The closing of the New Covenant Charter School at the end of the 2009-10 school year caused District schools to absorb a number of students in the 2010-11 school year, as evidenced by the high survival ratios for that year. Accordingly, these survival ratios were given less weight in determining the ratios used to project future enrollment.

As noted earlier, historical pre-kindergarten enrollment has varied greatly. Additional uncertainty is apparent because it, unlike kindergarten, is unmandated, making projections subject to volatility. Because of the uncertainty, a 4 year average (2008-09 through 2011-12) was used to project to the next five.

Kindergarten projections take into account projected charter school enrollment as part of our analysis of historical and future trends. We assume that there will be no changes in charter school status and the number of charter schools in the District.

With the recent opening of the Brighter Choice Middle Schools, the historical survival ratios for the middle school grades are not a reliable indicator of future enrollment, thereby decreasing the veracity of the projections. The addition of a 7th grade class in both the Brighter Choice Middle Schools in the 2012-13 school year adds to the uncertainty associated with the projections. Because of this uncertainty, a 3 year average (2009-10 through 2011-12) was used to project to the next five. As noted previously, the expansion and contraction of charter schools impacts public school enrollment, and requires continuous and constant monitoring.

Both in-district and out-of-district special education students are projected by taking the ratio of special education students to non-special education students in the current year and projecting it forward.

2012-13 through 2016-17 Enrollment Projections

- Overall enrollment is expected to dip in 2013-14, then increase to 8,899 in 2016-17.
- PK 5th enrollment is projected to gradually increase to the mid 4,500s by 2016-17.
- $6\text{th} 8^{\text{th}}$ grade enrollment is expected to remain in the mid-1,400s.
- 9th 12th grade enrollment is projected to decrease to 1,910 in 2013-14, then hover around the mid-1,900s through the end of the projection period.
