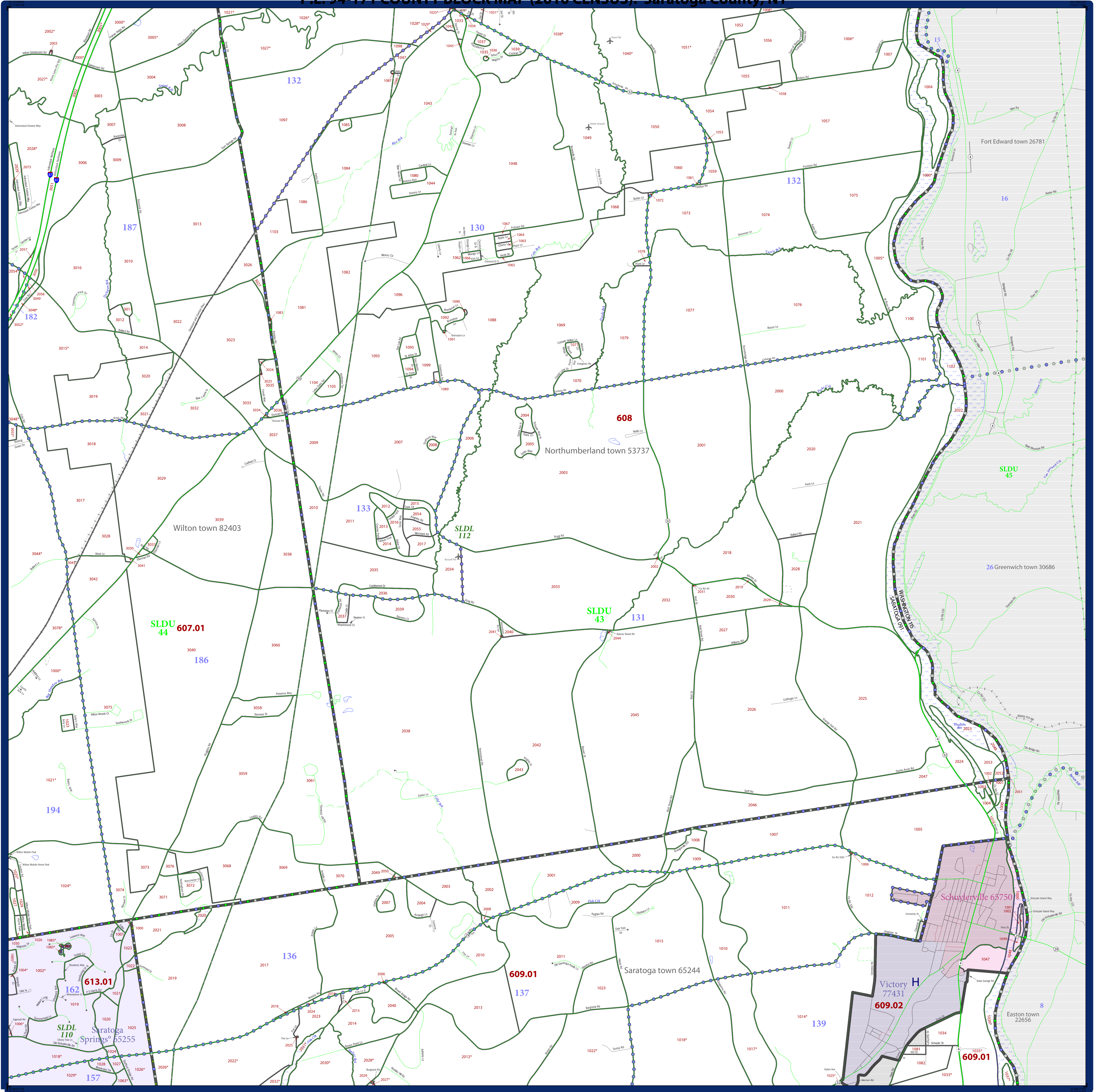


P.L. 94-171 COUNTY BLOCK MAP (2010 CENSUS): Saratoga County, NY

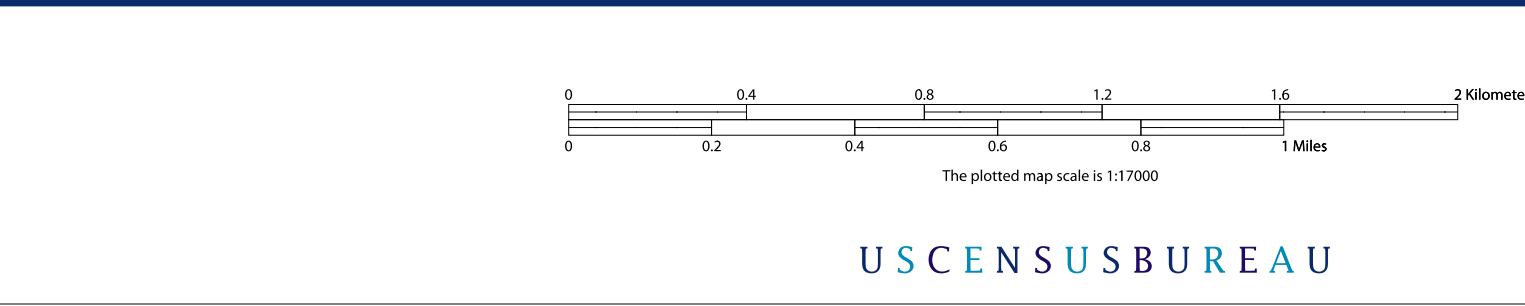
² Place label color correlates to the place fill color.
